



RhotKing LLC – Terms of Service

Effective Date: November 2025

1. Agreement to Terms

By accessing or using www.rhotkingcarrental.com ("Website"), you acknowledge and agree to be bound by these Terms of Service ("Terms"). If you do not agree, you must immediately discontinue use.

2. Description of Services

RhotKing LLC provides fleet management, listing support, guest communication, pricing optimization, photo management, and payout processing. RhotKing is not a bank, insurer, or guarantor of earnings.

3. Partner Eligibility and Obligations

Partners must own or be authorized to manage the vehicle, maintain registration and insurance, list RhotKing as additional interest, remit payments through Relay, and maintain vehicle condition.

4. Earnings, Payments, and Fees

Profit split: 70/30 in year one; 60/40 thereafter unless agreed otherwise. Payouts are in USD. No earnings are guaranteed.

5. Insurance and Risk Management

Partners must maintain rental-approved insurance with RhotKing LLC listed as additional interest. Insurance lapses allow immediate termination.

6. Maintenance, Repairs, and Damage

Partners are responsible for maintaining their vehicle. RhotKing may coordinate repairs but is not financially responsible unless in writing.

7. Liability and Limitation of Damages

RhotKing is not liable for indirect, incidental, or consequential damages. Partners indemnify RhotKing for third-party or vehicle-related losses.

8. Termination

Either party may terminate with written notice. Balances must be settled within 14 business days. Immediate termination applies for fraud, insurance lapse, or violations.

9. Intellectual Property Rights

A. Ownership

All content—including text, photos, logos, branding, layouts, and systems—is exclusive property of RhotKing LLC and protected under U.S. IP law.

B. Prohibited Use

Unauthorized copying, reproduction, scraping, mirroring, or imitation of content or business methods is strictly prohibited.

C. Partner-Specific Image Use

Partners may take photos ONLY of vehicles they personally own. All edited, enhanced, or RhotKing-created images remain property of RhotKing LLC. Non-partners may not reuse or capture any images.

D. Enforcement

Violations may result in DMCA takedowns, civil penalties, and legal action.

10. Proprietary Business Model Protection

RhotKing's operational workflows, systems, payout structures, and templates are proprietary trade secrets. Replication is prohibited.

11. Website Use Restrictions

Unauthorized access, scraping, data-mining, reverse engineering, or copying is prohibited.

12. Data Privacy
